

2024 Continuity of Care Program

This program is designed to support your outreach to members for annual visits and condition management, which will help us better identify members who are eligible for case management. Providers are eligible for a bonus for each completed Appointment Agenda (Health Condition History only) with verified and documented diagnoses on qualified claims.

New for 2024, bonuses increase when Appointment Agendas are submitted electronically via the secure provider portal, RxEffect, etc.

EMR Connectivity

Through EMR Connectivity, Risk Adjustment Point of Care Alerts (POCA), are pushed into and received back from the providers EMR, providing physicians with data they need to ensure members are being fully assessed each year.

Applicable EMR Systems:

- **AthenaHealth:** EMR implementation began April 2023 with Athena Moment of Care, allowing both Risk Adjustment and Quality Care Gaps Exchange between Providers and Centene for Medicare and Market-place products.
- eClinicalWorks: Allows Risk Adjustment condition exchange along with Quality Care Gaps under Healow Insights for Medicare, Marketplace, and Medicaid Products
- Epic Payer Platform (EPP): Currently we are working with Clinical Data Exchange allowing the automated electronic release of medical records and beginning implementation of Member Insights-CDS. CDS allows real-time decision support for clinicians in-workflow at the point-of-care for Medicare products.
- **Moxe Health:** Allows multiple EMR systems connectivity via Convergence. Currently, we can push Risk Adjustment open conditions for Cerner and Epic (not willing to connect via EPP) EMR users. Moxe has an extensive 13-week implementation process for both Medicare and Marketplace products.

Congenital Syphilis Resources Survey

Measure Spotlights

CBP – Controlling High Blood Pressure

This measure evaluates the percentage of members, ages 18-85, who had a diagnosis of Hypertension and whose blood pressure was adequately controlled (<140/90 mm Hg) during the measurement year.

Tips and Best Practices:

- If the blood pressure result is >140/90 mmHg, recheck it at the end of the visit and document this in the patients chart
- Ensure you are coding both Systolic and Diastolic values each time
- Member-reported blood pressure readings and blood pressure readings collected via telehealth are acceptable. Remote monitoring devices are not required to prove readings.
