# 2024 Meridian Foster Care Pay for Performance (P4P) Program

This program is designed to support your outreach to members for annual visits and condition management, which will help us better identify members who are eligible for case management. Providers are eligible for a bonus for each completed Appointment Agenda (Health Condition History only) with verified and documented diagnoses on qualified claims.

New for 2024, bonuses increase when Appointment Agendas are submitted electronically via the secure provider portal, RxEffect, etc.

Chlamydia Screening in Women (Total)	\$50
Childhood Immunizations - Combo 10	\$50
Immunizations for Adolescents - Combo 2	\$50
Lead Screening in Children	\$50
Well-Child Visits in the First 30 Months of Life - 6+ visits in the first 15 months of life*	\$50*
Well-Child Visits in the First 30 Months of Life - 2 visits from 15-30 months of life*	\$50*
Child and Adolescent Well-Care Visits*	\$50*

\*If well-child/adolescent well-care visit is completed for a member within 30 days of entering foster care, the incentive amount will increase to \$100.

### **Measure Spotlights**

### **COL – Colorectal Cancer Screening**

This measure evaluates the percentage of members/patients 45-75 years of age who had appropriate screening for Colorectal Cancer.

#### **Tips and Best Practices:**

- Ensure members/patients complete the Colonoscopy during the measurement year or nine years prior
- Ensure members/patients complete the Stool DNA (sDNA) with FIT Test or Cologuard during the measurement year or two years prior
- Ensure members/patients complete the Fecal Occult Blood Test (FOBT) during the measurement year
- Member-reported screenings are acceptable if documented in the chart as part of the member's history
- Support Colonoscopy scheduling at accessible in-network facility during patient visit and have referrals easily accessible or standing orders
- Reach out to your QPA/PQL to find out if your patient received a FIT home test kit from the Health Plan
