QUALITY

Sickle Cell Disease Program

Did you know MeridianHealth has a Sickle Cell Disease Program? This program aims to improve preventive care for children and adolescents with sickle cell disease by partnering and increasing collaboration with providers. The goal of the program is to work together in order to provide quality care and to increase compliance for routine-care, vaccinations, antibiotic prophylaxis, and Transcranial Doppler (TCD) ultrasounds.



EDUCATION

Michigan Department of Health and Human Services (MDHHS) Healthy Michigan Plan (HMP) Eligibility Changes Effective January 1, 2020, MDHHS will require HMP members to report at least 80 hours of work or other qualifying activities monthly to maintain healthcare coverage. Some beneficiaries will be exempt from these requirements based on certain criteria. Providers whose scope of practice qualifies them to assess an individual as medically frail will be able to complete a Medical Exemption Request form on behalf of a member. MeridianHealth (Medicaid) and MeridianChoice (Commercial) will go live with the new eviCore programs on November 1, 2019. The eviCore expansion includes the following programs: physical therapy (PT), occupational therapy (OT), genetic testing, pain management, and sleep studies. eviCore healthcare will begin accepting requests on October 21, 2019 for dates of service November 1, 2019 and beyond. Point of Sale Claims and Medicaid Enrollment

In accordance with Michigan Department of Health and Human Services (MDHHS) Bulletin MSA 19-20, beginning October 1, 2019, MeridianRx must reject Medicaid pharmacy claims for prescribers who are not enrolled with the Community Health Automated Medicaid Processing System (CHAMPS).
